1. ADDENDUM INTRODUCTION

The bidder has to consider uniformity of design, investment protection, streamlined processing and propose a suitable backup solution amongst the options below and provide the complete details in Addendum 2: Appendix 01 – Bill of Materials

Option 1: Augment the existing IBM Spectrum Protect backup solution

In case the bidder proposes option 1 then the bidders are expected to meet the below mentioned technical requirements and supply the below mentioned quantities as part of Option 1

- 1. Propose a LAN free backup software which should be same or extension of the existing IBM Spectrum Protect backup software.
- 2. Agent licenses should be considered only for server cores in the base machines of the blade servers irrespective of the number of VMs.
- 3. Additional PVU-based licenses of IBM Spectrum Protect backup software to backup multiple numbers of Virtual machines hosted on the servers.

The hardware and license quantity is as defined in the table below, which the bidder must supply through this RFP in case the bidder chooses Option 1.

Option 2: Propose an alternative backup solution which can co-exist with the existing backup solution setup

The bidder is required to propose an alternative backup solution which is latest generation equivalent of items in Option 1 and meeting the Addendum 2 – Annexure 1 – Minimum Eligibility Criteria. This backup solution should be LAN free and licenses should be based on the server cores irrespective of the number of VMs on the servers.

 - In a RFP, either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same RFP.
- 6 If an agent submits bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same RFP for the same item/product.
- 7 The decision of the bank shall be final and binding in this regard. Any deviations will be ground for disqualification.
