<b>New Clause</b>
Bidder's liability to Kerala Gramin Bank under this RFP is limited to the amount payable by Kerala Gramin Bank to Bidder for the relevant Order. This provision does not limit either party's liability for: unauthorized use of intellectual property, death or bodily injury caused by their negligence; acts of fraud; wilful repudiation of the Agreement; nor any liability which may not be excluded or limited by applicable law.
