DETAILS OF THE RFQ AND TERMS & CONDITIONS

We, Kerala Gramin Bank, a Regional Rural Bank, having its Head Office at KGB Towers, A K Road, UP Hill, Malappuram, Kerala-676505, invites quotations from eligible vendors for the supply of Flatbed scanners for the use of our branches, on buy-back of old HP Scanjet HP 2410 scanners, based on the following terms and conditions:

- 1. The bidder should be an authorised dealer of Flatbed Scanners or Original Equipment manufacturer (OEM).
- 2. The Bidder should have a valid GSTIN.
- 3. Quantity: 65 numbers (with a provision for +/- 10% variation). The actual number of new scanners required and old scanners disposed on buy-back will be specified in the Purchase Order.
- 4. Specification: As mentioned in Part-B of this RFQ.
- 5. Place of Delivery:-

- 6. Delivery Terms: Within 2 weeks from the date of Purchase Order.
- 7. Payment Terms:
 - a. 97% on completion of delivery and testing
 - b. 3% on submission of Performance Bank Guarantee (PBG) or on completion of Warranty Peiod Whichever is earlier. (The format of PBG will be provided by Kerala Gramin bank to the successful bidder)
- 8. Invoice should be submitted to the Bank's Head Office, along with delivery report duly counter-signed by our officials in the respective delivery sites. GSTIN of Kerala Gramin Bank is 32AACAK1498D1ZX.
- 9. Duly signed and sealed Technical Compliance sheet in the format given in Part-B of this RFQ, should be enclosed in an envelope superscribed as "Technical Compliance for Flatbed Scanners" and the duly signed and sealed Commercial Bid in the format specified in part C of this RFQ, should be enclosed in another envelope superscribed as "Commercial Bid for Flatbed Scanners". Both these envelops should be enclosed in a larger sealed envelope supescribed as "Bid for

Flatbed Scanners" and sent by post or courier or handed over directly to The Asst. General Manager, Kerala Gramin Bank, Head Office, IT Wing, Up-hill, AK Road, Malappuram-676505.

- 10. Online submission of the bids is not acceptable.
- 11. There should not be any change in the format of the Technical Compliance Sheet and Commercial Bid, specified in this RFQ.
- 12. The Quotations should reach our Head Office on/before 09.12.2022 (3.00 PM). Quotations received after the stipulated time will not be considered for evaluation.
- 13. The Technical Compliance sheet will be opened at 3.30 PM on 09-12-2022 in the presence of bidders' representatives whoever choose to be present on the occasion.
- 14. The Technical Compliance Sheet will be scrutinized on the same day and the commercial bids of technically shortlisted bidders will be opened at 4.30 PM on 09.12.2022, in the presence of bidders' representatives whoever choose to be present on the occasion.
- 15. The Purchase Order will be generally placed to the L1 Bidder (Successful Bidder), who complies with all technical requirements. The Successful Bidder should accept the PO within the timeline stipulated in the Purchase Order.
- 16. In case the L1 Bidder does not accept the bid within the stipulated timeline or fails to deliver the scanners within the specified period of time, the Bank may, at its sole discretion, consider cancelling the order placed with the L1 Bidder and placing the order with the L2 Bidder.
- 17. Kerala Gramin Bank reserves the right to place purchase order with any vendor under this RFQ process or to cancel the process, without assigning any reason for cancellation.
- 18. The successful bidder shall enter in to an agreement with Kerala Gramain Bank within 21 days of accepting the purchase order.
