Only vendors empaneled with Canara Bank, having relevant experience in providing consultancy services for transformer and generator installations, are eligible to submit quotations.

4. Scope of Consultancy Work:

❖ Technical Assessment:

- Conduct a thorough site assessment of the current infrastructure and electrical setup at the Head Office.
- ♣ Evaluate the existing 125 KVA generator and transformer to understand the requirements for a seamless upgrade.
- ♣ Provide recommendations on the technical specifications for the new 315 KVA transformer and 320 KVA generator.
- ♣ Ensure proper connection of the generator and transformer to the existing infrastructure.

Project Planning and Design:

- Prepare a detailed report plan for the dismantling of the old equipment and installation of the new systems.
- ♣ Design the layout, including civil and electrical works, wiring, and cabling needed for the new installation.
