- 1.An agreement in this regard shall have to be executed between the Bank and your Courier service agency. Draft copy of agreement shall be sent to successful agency on confirmation of quote. Courier agency should have valid GST registration.
- 2.Successful agency shall have to deposit an amount of Rs.50,000/-(Rupees Fifty Thousand only) with our Bank towards the security amount for 3 years period for the due performance of the contract which shall be refunded to you after expiry of the contract period or at time of cessation of the contract period if everything is in order.
- 3. The arrangement is for the services effective for 2 years. However the Bank may for any reasons whatsoever discontinue/terminate the contract by issuing a notice of 7 days to you. If the highest bidder is ready to match fix the rate with L1 quote then they will also be considered for rendering their service to selected centers purely at the discretion of bank.
- 4.Delivery time: Within 24 hours to branches/offices/other addressees within Kerala and 48 hours to other states.
- 5. The rate quoted by you should be final and there will not be any revision / hike on the rate under any circumstances during the contract period.
- 6. Selection will be based on rate quoted and frequency of service provided.
