Quotes are invited from reputed manufacturers/suppliers for supplying hand sanitizer for the use of Branches and Offices of the Bank up to 31-03-2021 as per the specification mentioned below.

1. General conditions

- Manufacturers /Dealer /Distributor/Sole Selling Agent having 2 years' experience in the field.
- Rates are to be quoted in Indian Rupees (INR) only.
- Manufacturer of hand sanitizer having valid test certificates and Drug/ Cosmetic License issued by Competent Authority and Dealer /Distributor/ Sole selling agent duly authorized by the manufacturer for selling their hand sanitizer can participate in the tender.
- The rate quoted should be net, i.e. inclusive of all charges, taxes, GST, packing, transporting charges and all other expenses.**
- HDPE Cans containing hand sanitizer should be supplied to various branches /offices situated at different location of Kerala at the cost of suppliers.
- Rates to be quoted zone wise for i) Supply to individual Branches (**Annexure I**) and ii) Supply to Cluster Head Branches (**Annexure II**).
- List of these branches/offices is annexed with this Tender notice. Number of cans containing hand sanitizer to be supplied to these branches/offices will be informed at the time of placing final order.

2. Jurisdiction

In the event of any dispute arising out of the tender, such dispute will be under the jurisdiction of the Honorable Civil Courts in Malappuram Only

3. Quotes

The tender is "**Two Envelope Concept**" (Envelope No-1-Technical bid, Envelope No.2-Financial bid).

- I. **Envelope No.1-Technical bid**- All quotes should contain information regarding manufacturing license from the competent authority(if applicable), experience, expertise in the line of activity, capacity to supply large quantity within a specified time, the names & addresses of existing large clients and copy of last two years' financial statements , Proforma –A and checklist.
- II. **Envelope No.2- Financial Bid**- The actual price quote in Proforma - B.

4. Mode of submission of quote

Technical bid shall be placed in a sealed cover superscribed "**Envelope -1Technical Bid for Enquiry No:34/2020** " and Financial bid in a separate sealed cover superscribed "**Envelope -2-Financial bid for Enquiry No:34/2020**" with full postal address, phone numbers, mail ID of the tenderer.

- b) Kerala Gramin Bank reserves the right to accept or reject any/all quotation without assigning any reason whatsoever.
- c) Any tender received after the due date & time will not be considered. The tender will be received through Regd. Post/Speed Post/ Courier only.
- d) The Rate Contract once approved should remain valid till 31.03.2021 from the date of approval.
- e) Bidder who has been blacklisted either by the Tender inviting authority or by any State Govt./Union Territory/Govt. of India/Govt. Organization/Govt. Health Institutions for supply of Not of Standard Quality Items /non-supply is not eligible to participate in the tender during the period of blacklisting.
- f) The decision of the committee constituted for finalization of the selection of the supplier will be final and binding.
- g) The hand sanitizer should be delivered to the Bank within **10** days from the date of receipt of final supply order from the Bank.
- h) The payment shall be made to supplier after satisfactory completion of delivery of items and observing all legal formalities.
- i) Hand sanitizer should be supplied in lot to the above branches/offices at the cost of supplier. The number of cans to be supplied to each office and detailed address will be informed to the successful bidder while placing the final supply order.
- j) Kerala Gramin Bank has 634 Branches (See Annexure I).These branches come under 10 Regional Offices .The total branches are divided in to three zones viz. South Zone ,Central Zone and North Zone for this purpose. Each zone covers branches under three to four Regional Offices as per list attached.
