A. Introduction:

KERALA GRAMIN BANK (hereinafter referred to as "The Bank" or "The Purchaser" in this RFP), a body Corporate and a premier Regional Rural Bank established in the Year 2013 by amalgamating erstwhile North Malabar Gramin Bank and erstwhile South Malabar Gramin Bank, having its Head office at KGB Towers, AK Road, Malappuram, Kerala-676505. The Bank is having pan Kerala presence with 634 branches and 269 ATMs. The Bank is a forerunner in implementation of IT related products and services and continuously making efforts to provide the state of art technological products to its customers.

RBI vide letter No RBI/2021-22/71 dated 12.07.2021 has instructed all the Banks to use lockable cassettes in all ATMs of the bank by 31.03.2022. Presently, the Bank has 247 ATMs installed at various locations within the state of Kerala Gramin Bank and their model and make is as under:

- Make :NCR
- Model: Self Serv 22 & Self Serv SE Cash

Bank is looking for **Purchase of lockable Cassettes and lockable Purge Bin for above mentioned make of ATMs** to comply with the instructions of RBI.

B. GENERAL INSTRUCTIONS

1. Contacting the purchaser

- 1.1 The eligible bidder shall submit its bids/quotes strictly as mentioned in RFP document being floated by the bank on prescribed format.
- 1.2 Any effort by the bidder to influence the Purchaser in evaluation of the purchaser's bid, bid comparison, or contract award decision may result in the rejection of the Bidder's bid. Purchaser's decision will be final and without prejudice and will be binding on all parties.

2. Purchaser's right to accept or reject any bid or all bids

- 2.1 The Bank reserves the right to accept or reject any bid and annul the bidding process or even reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or without any obligation to inform the affected bidder or bidders about the grounds for the purchaser's action.
- 2.2 The Bank is not bound to accept lowest or any BID received.

3. Scope of Work

The bank is looking for vendor/Company which will supply and install Lockable

cassettes in each location. The following are the specifications of lockable cassettes for NCRmake:

3.1 Technical Specifications of the lockable cassettes for NCR make ATMs:-

3.1.1 The Cassettes should be molded in high impact polycarbonate and designed to store currency.

3.1.2 The cassette's external dimensions are -

Height	:	13 cm
Width	:	22 cm
Depth	:	38.5 cm

3.1.3 The cassette can be configured to hold currency of different length and widths and to indicate a code for the denomination it contains

Currency Length Range	:	12 to 177 mm (4.7 to 7.0 in)
Currency width range	:	62 to 85 mm (2.4 to 3.4 in)

3.1.4 Also cassettes should contain,

- a. Spacers for height adjustment.
- b. Holds up to 2500notes.
- c. Uses key to open.
- d. Requires configuration for specific denomination before use.

3.1.5 External dimensions of lockable purge bins:

Length=18.8 cm
Height=20.8 cm
Width=10.2 cm

3.2 Eligibility Criteria for Supply and Installation lockable cassettes

3.2.1 This RFP is open to all firms / Companies within India which are carrying business in India under relevant laws as in force at the time of bidding should fulfil the eligibility conditions subject to the following requirements:

- a. The Service Provider should have supplied these cassettes to at least two different Private/ Public/ scheduled banks.(Quantity more than100).
- b. Supplier should have resource or resources to calibrate cassettes as per desired currency denominations within Kerala.
- c. Supplier should have at support Engineers available in Kerala to resolve the problems /complaints in a time bound manner.

4. Period of validity

Bids shall remain valid for a period of 6 months from the date of bid opening decided by the Purchaser. A bid valid for shorter period shall be rejected by the purchaser as non- responsive.

5. Bid Currency

The prices in the bid document shall be expressed in Indian Rupees only.

6. Bidding Process:

For the purpose of the present project, a two stage bidding process will be followed. The response to the present tender will be submitted in two parts:

Part I : Basic Eligibility-cum-Technical Proposal
Part II : Commercial Bid

The two parts as stated above should be placed in two separate envelopes super scribed respectively with 'Technical Proposal' and 'Commercial Bid' and properly closed and sealed. Thereafter, both these envelopes should be placed inside a large envelope and properly closed and sealed. The final envelope should be super scribed with the wordings "KGB/DBS/RFP: 02/2022 dated 08.02.2022. Enclosed: (separately sealed Technical Proposal and Commercial Bid)" on the top of the envelope.

6.1 Eligibility Conformity and Technical Compliance

- 6.1.1 Conformity to Eligibility Criteria should be submitted as per the instructions in ANNEXURE-II (Part A) and compliance to Technical requirements should be provided as per ANNEXURE-II (Part B).
- 6.1.2 Before submitting the bid, the bidder should ensure that they conform to the basic eligibility criteria and comply all technical requirements as stated in this RFP. Only after satisfying their selves of the eligibility, the offer should be submitted.
- 6.1.3 Along with ANNEXURE-II, Bidder must submit DD (Application Fee) and EMD or Bank Guarantee (BG format as in APPENDIX A) in lieu of EMD. Bank Guarantee may be obtained from any of the Scheduled Banks.
- 6.1.4 Technical bid shall not contain any pricing or commercial information at all.
- 6.1.5 The bid shall be typed or written in indelible ink and shall be signed by the Bidder or person duly authorized to bind the bidder to the contract. The authorization shall be indicated by a written power of attorney accompanying the bid.
- 6.1.6 All pages of the bid except un-amended printed literature shall be initialed by the person(s) signing the bid.
- 6.1.7 The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder, in which case corrections shall be

initialed by the person(s) signing the bid.

- 6.1.8 **Masked 'Bill of Material'** must be attached in Technical Offer and should not contain any price information (**Price fields to be marked with 'X'**). Here, 'Masked' means that there should not be any prices mentioned in the Bill of Materials. All the price fields should be marked with a 'X'.
- 6.1.9 The Technical Proposal (containing Bid Covering Letter as per Annexure-I, Authorization form signed by the Board/CEO/MD/Managing Partner authorizing its representative to sign in the Bid documents on their behalf, Basic eligibility declaration-cum-Technical proposal as per Annexure-II and other documents mentioned therein, DD towards price of bid documents, EMD/BG, masked commercial bid etc.) should be sealed in a separate Envelope with **"KGB/DBS/RFP 02/2022 dated 19.02.2022- Technical Proposal"** to be super scribed on the top of the cover. The envelope shall bear the name and complete postal address of the Bidder, RFP No. and the authority to whom the Bid is submitted. The envelope should be properly sealed and any envelope found unsealed will lead to disqualification of the Bidder.

6.2 Commercial Bid

- 6.2.1 Commercial Bid shall be submitted as per the Bill of Material and other terms and conditions of RFP on prices.
- 6.2.2 Bidder should invariably quote the price for **buy-back of old currency cassettes, including purge bins** (non-lockable) invariably in the format for commercial Bid as per ANNEXURE-III.
- 6.2.3 The Commercial Bid should give all relevant price information as per ANNEXURE-III. Any deviations from the Bill of Material / non-submission of prices as per the format shall make the bid liable for rejection.
- 6.2.4 The bidder should quote the price in Indian currency on the prescribed format as per ANNEXURE-III.
- 6.2.5 The rates quoted should be valid for a minimum period of 6 months.

6.3 Submission of bids

- 6.3.1 The sealed covers containing all the three parts (Eligibility Conformity, Technical Proposal and Commercial Bid) should be addressed to:

6.3.2 The bid documents should be submitted as per Bid schedule furnished above in the RFP.

6.4 Earnest Money Deposit

- 6.4.1 Bidder has to submit the bid earnest money of Rs1,00,000/- (Rs. One Lakh only) in the form of demand draft (DD) favoring Kerala Gramin Bank payable at Malappuram or Bank Guarantee (BG) as per the Bank Guarantee format provided in ANNEXURE-V to this RFP.
- 6.4.2 Exemption from EMD is available only for MSEs and start-ups, provided they submit all relevant proof and special request in prescribed form (provided in ANNEXURE-VI). However, no relaxation is applicable to such Bidders in basic eligibility criteria.
- 6.4.3 In the case of other non-MSE Bidders, the proposals without EMD will be rejected straight away. No interest will be paid for EMD.
- 6.4.4 In case EMD is submitted in the form of DD, the name and address of the Bidder should be written on the backside of the DD. The EMD of the unqualified Bidders will be returned within 15 days after opening the commercial bid. The EMD deposited by the vendor shall be forfeited if the selected vendor fails to complete the project within the time period agreed mutually by the bank and the vendor.
- 6.4.5 If submitted in the form of BG, it should be valid for a period of six (6) months and an additional claim period of three (3) months.

6.5 Deadline for submission of Bids

- 6.5.1 Bids must be received by the purchaser at the address specified in the Bid Document not later than the specified date and time mentioned in the bid document. If the specified date of submission of bids being declared a holiday for the purchaser, the bids will be received up to the specified time in the next working day.
- 6.5.2 The purchaser may, at its discretion, extend this deadline for submission of bids by amending the bid documents, in which case all rights and obligations of the purchaser and bidders, previously subject to deadline, will thereafter be subject to the deadline extended.

6.5.3 Late bids

Any bid received by the purchaser after the deadline for submission of bids will be rejected and/or returned unopened to the bidder, if so desired.

6.6 Modification and withdrawal of bids

- 6.6.1 Bids once submitted will be treated, as final and no modification will be permitted. No correspondence in this regard will be entertained.
- 6.6.2 No bidder shall be allowed to withdraw the bid after the deadline for submission of bids.
- 6.6.3 In case of the Successful Bidder, the bidding firm will not be allowed to withdraw/back

out from the bid commitments. The bid earnest money in such eventuality shall be forfeited and all interest /claims of such bidder shall be deemed as foreclosed.

6.7 BID Opening and Evaluation

- 6.7.1 The Purchaser will open bids, in the presence of Bidders/ their representatives who choose to attend, at time and date mentioned in Bid schedule at the address mentioned in Para-“Submission of Bids”.
- 6.7.2 The bidders/ their representatives, who are present, shall sign the register/ attendance sheet evidencing their attendance. In the event of the specified date of bid opening being declared a holiday for purchaser, the bids shall be opened at the specific time and place on next working day.
- 6.7.3 In the first stage, Technical Proposal containing basic eligibility conformity and technical compliance only will be opened and evaluated. Those bidders satisfying the eligibility requirements and fulfilling the technical requirements and accepting the terms and conditions of this document shall be shortlisted.
- 6.7.4 The purchaser reserve the right to accept or reject any technology proposed by the bidder without assigning any reason thereof. Decision of the purchaser in this regard shall be final and binding on the bidders.
- 6.7.5 In the second stage, the commercial bids shall be opened in the presence of short listed vendors, whoever chose to be present at the specified venue on the occasion. If the shortlisted bidders or their duly authorized representatives are not present, the commercial bids will be opened in their absence.

6.8 Clarifications of Bids

- 6.8.1 The Bank will examine the commercial bids to determine whether they are complete; whether any computational errors have been made; whether required information has been provided as underlined in the bid document; whether the documents have been properly signed and whether bids are generally in order. Bids from agents without proper authorization from the manufacturer as per the authorization form shall be treated as non-responsive and will be outrightly rejected.
- 6.8.2 Arithmetic errors will be rectified on the following basis. If there is a discrepancy between unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and total price shall be corrected. If there is discrepancy between words and figures, the amount in words will prevail. The bid determined as not substantially responsive will be rejected by the purchaser.

6.9 Evaluation of Bids and Placing of Order

- 6.9.1 The Commercial bids of only those bidders who fulfil the basic eligibility criteria and technical criteria will be considered for opening. Among the technically shortlisted bidders, the bidders will be ranked on the basis of the total price quoted, net of buy-back value of old cassettes.
- 6.9.2 The Bidder quoting the lowest net price will be normally declared as the Successful Bidder.

However, placing the order with the L1 Bidder is at the sole discretion of the Bank.

6.10 Acceptance of order

The Successful Bidder should accept the Purchase Order within 7 days of issue of the confirmed order, failing which The Bank has a right to cancel the order.

6.11 Rates

The rates should be inclusive of all taxes and Govt. levies. However, taxes and basic price should be indicated separately.

7. Warranty

All Lockable cassettes should be with Six months' warranty.

8. Payment terms

8.1 Payment for providing Purchase of Lockable Cassettes shall be released as follows:

- a. 90% upon supply of the items at all the specified locations and subject to submission of delivery confirmation countersigned by the respective Branch Manager.
- b. Balance 10% after completion of 6 months' warranty period or upon submission of a Performance BG for 6 months with an additional claim period of 3 months. (The format of the BG will be provided to the Successful Bidder).

9. Governing Law and Disputes

9.1 Both parties shall make every effort to resolve amicably through negotiations, any disagreement or dispute arising between them under or in connection with the agreement.

9.2 Any dispute or differences what so ever arising between the parties which cannot be resolved amicably, both the parties shall proceed for arbitration.

9.3 During the arbitration proceedings the vendor shall continue to work under the contract unless otherwise directed in writing by the Bank or unless the matter is such that the work cannot possibly be continued until the decision of the arbitrator, as the case may be, is obtained.

9.4 In the case of legal proceedings, the area of jurisdiction will be Ernakulum.

10. Supply- Terms and Conditions

10.1 Delivery locations

The delivery locations are the link branches of the respective ATMs. The list of locations are

furnished in ANNEXURE-IV.

10.2 Delivery Terms:

The delivery of all the lockable cassettes should be completed by the Successful Bidder in all specified locations within 8 weeks of acceptance of purchase order or within 9 weeks of issue of the purchase order.

10.3 Delay/ defect in the vendor's performance

10.3.1 In case the items supplied by the Successful Bidder is found to be damaged, already used or of sub-standard quality, The Bank deserve the right to reject the items and to forfeit the EMD or invoke the BG.

10.3.2 In case of delays in supply of the entire lot of ordered items within the stipulated period of time mentioned in clause 7.3 above, a penalty at the rate of Rs.100/- per day beyond the stipulated date, per location. The penalty, in any case will not exceed 10% of the ordered value. However, the Bank deserves the right to discontinue the contract, if the delay exceeds 4 weeks beyond the permitted period of time.

11. Execution of Agreement

11.1 The Successful Bidder shall execute an agreement with The Bank in line with this RFP terms within 15 days of acceptance of the purchase order.

11.2 Use of contract document and information:

The vendor shall not, without the purchaser's prior written consent, make use of any document or information provided by the purchaser in Bid document or otherwise except for purpose of performing contract.

12. Assignment/Sub-Contract

The vendor shall not assign or sub-contract to anyone, in whole or in part, its obligation to perform under the contract, except with the Bank's prior written consent.
