5. Other Terms and Conditions

- 1. The purchase order will be generally placed to L1 bidder(Successful Bidder). The methodology for computing L1 is the total cost incurred by Bank in procuring the ACs ie (total cost of new Acs). The successful bidder should accept the PO with in the timeline stipulated in the Purchase Order.
- 2. In Case the L1 bidder does not accept the bid within the stipulated timeline or fails to deliver the same within the specified period of time, the Bank may at its sole discretion consider cancelling the order placed with L1 bidder and placing the order with the L2 bidder provided he is agreeable for providing ACs at L1 rate or to L3 bidder on the refusal of L2 bidder. In that case L3 bidder should also be ready to supply ACs at the rate quoted by the L1 bidder.
- 3. After the award to L1, if the selected Bidder does not perform satisfactorily or delays the execution of the contract, the Bank reserves the right to get balance contract executed by another party of its choice by giving 15 days notice for the same. In this event the selected bidder is bound to make good additional expenditure ,which bank may have to incur to carry out the execution of the balance of the contract. This clause is also applicable if for any reason the contract is cancelled.
